Speicifications of dedicated wired LAN

- Conforms to IEEE 802.3,802.3u and 802.3ab Ethernet standards, Ethernet RJ45 connection.
- Communication speed has no option, 100Mbps and more for downloads, 10Mbpsand more for uploads.
- Globally routable unicast public IP address shall be allocated, not shared private IP address.
- One wired line allows only one device connection in principle.
- 10m long wire supplied as standard, and longer wiring available upon request and consumer's cost.

Specifications of wireless WiFi connection

- Conforms to IEEE 802.11ac and 802.11b/g/n.
- Allows 5GHz 867Mbps wireless connection, and 2.4GHz 300Mbps as well.
- Supports 802.1x wireless security.
- Secured access to WiFi with password
- Each WiFi needs a dedicated wired LAN which the exhibitor shall order.
